*All that piece parcel and tract of land lying situate and being in Bates Township, State and County aforesaid known as a part of the land conveyed to me by deed from H. H. and M. Hendricks and in the division as tract no. (3) three, adjoining lands of J. B. Keeler and tract no. 2 & others, beginning on a stone J. B. Keeler corner, thence running N. 80.12' W. 22.25 ch. to a stone, thence S. 34 1/4 W. 22.20 to a stone at the head of a branch, thence S. 31 E. 17.20 to an iron pin thence N 42 E. 39.00 to the beginning corner and contains 57 1/4 acres, be the same more or less.
