unto the said A. D. C. Backdale, all that certain tract, piece,parcel or lot of land situate, lying and being
in the City and County of Greenville, State of
South Carolina & record as part of Shumate property
having the following metes and bounds, to
beginning fronting sixty feet on Forrest Street, and
running back an parallel lines one hundred
and thirty (130) feet to lot No. 24 of survey of Wm. T.
Shumate property, lying between lots 19 and 21, and
measuring back to lot #24, and being lot #20
as shown on plat of Shumate land, as re-
corded in Volume 3 of at page 51, and more
particularly described in deed of conveyance
from Jelind L. Smith, as assignee to C. H. Jackson, et
al., recorded in R. Mr. C. Office for Greenville County
in Book P.P.S. at page 68, to which reference is
