KNOW ALL MEN BY THESE PRESENTS, That J. W. Thomason, of the  
County of Greenville

in the State aforesaid,  
in consideration of the sum of

Forty Five Hundred DOLLARS,

to me in hand paid

at and before the sealing of these presents by  
J. T. Bryant

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release  
unto the said J. T. Bryant, All that certain piece, parcel or tract of land situate, lying and

being in Dunklin Township, State and County aforesaid, containing one hundred and twenty-eight and one-half (128-1/2) acres, more or less, and consisting of three separate tracts, as follows:

No. 1- All that certain piece, parcel or tract of land purchased by J.L. Traynham from G.H. Ridgeway as per deed recorded in Vol. ZZZ, page 349, and sold to me by the said J.L. Traynham as per deed recorded in Vol. ZZZ, 351, containing originally one hundred and thirty-one and one-half acres; and described as follows:

Beginning at a Spanish oak; thence S. 27-1/2 E. 17.20 to a stone; thence S. 68-1/4 W. 43.38 to a poplar; thence S. 79 W. 25.15 to a stone (20 links from persimmon tree); thence N. 2-1/2 E. 23.00 to a stone; thence N. 76-1/2 E. 57.65 to the beginning corner (Note- From the conveyance of 142 acres in these two tracts by Traynham to Thomason, a tract of 18 acres has been sold off.)

No. 2- All that certain tract of land purchased by J.L. Traynham from Zora L. Ridgeway as per deed recorded in Vol. ZZZ, page 350, and sold to me by the said J.L. Traynham as per deed recorded in Vol. ZZZ, page 351, containing ten and one-half (10-1/2) acres, and described as follows:

Beginning at a stone on the public road to Fork Shoals; thence N. 53 W. 25.25 to a small poplar; thence S. 33 W. 6.80 to a stone on J.E. Knight's line; thence S. 35-3/4 E. 5.88 to a stone on G.H. Ridgeway's line; thence N. 82-1/4 E. 11.74 to stone; thence S. 25-1/4 E. 10.07 to stake on line of tract No. 1; thence up and along said line 5.25 to the beginning corner.

No. 3- All that piece, parcel or tract of land situate, lying and being in Dunklin Township, State and County aforesaid, on branch waters of Horse Creek, containing 4.13 acres and described as follows:

Beginning at stone next to Thomason's land; thence N. 35-1/2 W. 8.00 to a stake nm; thence S. 39-3/4 W. 10.63 to a pine 3x nm; thence S. 60-3/4 W. 2.60 to a stake nm; thence N. 77-35 E. 14.00 to the beginning corner. This is the same land purchased by me from J.E. Knight the deed for which is recorded in Vol. 11, page 435.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said
