(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released; and by these presents do Grant, Bargain, Sell and Release unto the said M. W. Scott, his heirs and assigns, all

that piece, parcel or tract of land situate, lying and being in the County and State aforesaid and having the following metes and bounds to wit:
 Beginning at a corner (small bridge) on the Fork Shoals Road, thence S. 48 W. 5.00 chs. to stone 3X thence S. 41 W. 2.90 to stone; thence S 8 W. 5.19 to stone thence S. 23 1/2 E. 4.10 to stone thence S. 62. W. 2.45 to Poplar 3X; thence N 35 1/2 W. 11.44 to iron pin in road; thence S. 12. 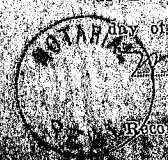
