Center deceased who was the son of Jesse Center; and only surviving heirs at law of in the State aforesaid, in consideration of the sum of Five Dollars to Wm. H. Lee and F. R. Daugherty and other considerations

at and before the sealing of these presents by W. H. Lee and F. R. Daugherty of Spartanburg, in the State aforesaid.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said W. H. Lee and F. R. Daugherty, all that certain

plantation or tract of land containing thirty acres or the same more or less; owned by our grand father Jesse Center above mentioned; Beginning on a white Oak, thence N. 38 chains to a chestnut; thence S. 70 E. 15 chains 50 links to a Spanish Oak; thence S. 57-50 chains to a white Oak stump; thence S. 15 E. 50 chains to a chestnut; thence S. 7 E. 10.50 to a red Oak; thence S. 55 W. 16 chains to a chestnut Oak; thence N. 23 W. 4 chains to a Hickory; thence S. 67 W. 7.50 chains to a Hickory, the same being part of the tract of land which I (Jesse Center) had bargained to William Howard said land being in Blasley Mt. Township, Greenville County, State of South Carolina.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said W. H. Lee and F. R. Daugherty their heirs and assigns, forever.

AND Wm. H. Lee and F. R. Daugherty do hereby bind

heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said W. H. Lee and F. R. Daugherty and their

heirs and assigns, against us and ours

heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
