DEED TO The Parker Land Co.

KNOW ALL MEN BY THESE PRESENTS, That S. F. Lowery, of the County of Greenville aforesaid,

In the State aforesaid,  
In consideration of the sum of Three Thousand (\$3,000.00) DOLLARS,  
to me in hand paid  
at and before the sealing of these presents by The Parker Land Company

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said The Parker Land Company

All those certain piece, parcels or tracts of Land, known as Nos. 66 and 67 of plat No. 2, of The Parker Land Company, dated April 1914, made by A.S. Bedell, the said two tracts containing twenty-four acres, more or less, and being bounded as follows, Viz:  
Tract No. 66: Beginning in Thackston's line, the northeast corner of The Parker Land Company's tract No. 65, and running with the line of tract No. 65, S. 13-24 W. 765 feet to a stake, corner of Tracts Nos. 65, 60 and 61; thence with the line of Tract No. 61, S. 87-13 E. 581 feet to a stake in the center of Burns Cross Road, the corner of tracts Nos. 61, 62 and 67; thence with the center of Burns Cross Road N. 24-2 E. 512.6 feet to a point in Thackston's line; thence with Thackston's line N. 63-47 W. 685 feet to the beginning, containing nine (9) acres, more or less.

Tract No. 67: Beginning at a point in the center of Burns Cross Road in line of The Parker Land Company and Thackston, being also the corner of lot No. 66; thence down Burns Cross Road S. 24-02 W. 512.6 feet to a point in the center of the road, corner of tracts Nos. 61, 62 and 66; thence with the line of tract No. 62, S. 53-30 E. 750 feet to a stake, the corner of tracts Nos. 62 and 63; thence with line of tract No. 63, N. 52-50 E. 7.56 feet to a point in the center of the old Thompson road, corner of tract No. 63; thence with the Thompson Road N. 53-40 W. 406 feet to bend in road; thence still with the road N. 46-43 W. 256 feet to a bend in the road; thence still with the center of the Road N. 61-13 W. 307 feet to a bend in the road; thence still with the center of the road N. 87-58 W. 143 feet to a point in the center of the Old Thompson Road on Thackston and Parker Land Company's line, corner of tract No. 69; thence with the said line S. 25-23 W. 109 feet to an iron, corner of Thackston and The Parker Land Company; thence along line of Thackston & Parker Land Co. <sup>N. 63-47 W.</sup> 10 feet to the beginning corner, containing fifteen (15) acres, more or less, being the same tracts of land conveyed to me by The Parker Land Company by deed bearing date December 17, 1914, and recorded in Vol. 22 page 122, R.M.C. Office for Greenville County.
