unto the said J. P. Ballinger,

All that certain piece, parcel and tract, lying  
and being in Greenville Township, State and County aforesaid,  
said, in section near Johnson Mill Village, and being  
Known as lot No. 50 of the J. R. West subdivision, as shown  
by plat made by W. S. Peacock, recorded in R. M. C. Office  
for Greenville County in Plat Book "C" at page 140, and  
being more fully described, as follows: Beginning at a  
point on an unnamed street or road in the said  
subdivision, front corners of lots Nos. 50 and 49, and  
thence along line of said lots 149, 1 feet to a  
stake, thence 56.6 feet to a point, joint corner of lots Nos.  
50 and 51, thence along joint line of lots Nos. 50 and 51  
114.9 feet to a stake on said unnamed street; thence
