and being south of Simpsonville just outside the town
limits on the Greenville and Laurens Road, having the
following meets and bounds to wit: Beginning on S. C.
Crisp Corner 3 $\frac{1}{2}$ thence in a Northly direction along said
Greenville and Laurens dirt Road One hundred and Sixty
Nine (169) feet to an iron pin 3 $\frac{1}{2}$ thence in a Westly
direction one hundred and seventeen (117) feet to an iron pin
3 $\frac{1}{2}$ thence in a Southly direction one hundred and Sixty
Nine (169) feet to an iron pin 3 $\frac{1}{2}$ thence in a Easterly
direction along S. C. Crisp line one hundred and seventeen
