(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *C.C. Bates and Grace Bates, share and share alike,*

their heirs and assigns; All that certain piece, parcel or tract of land situate, lying and being in Bates Township, Greenville County, South Carolina, on the East side of Jones Gap Road, and having the following metes and bounds, to wit: Beginning at the place on said road, and running thence with said road due S. 85° 52' E. 11.58⁵² to stake; thence N. 29° 15' 65³² to a S. 48° W. 9.58⁵² to stone. 23 acres more or less, according to survey made by J. Langford, and is the same tract of land sold to the said, Mrs. C. C. Montgomery, formerly Ellen C. West, her mother Mrs. C. C.
