DEED TO Emma J. Beam

KNOW ALL MEN BY THESE PRESENTS, That We, S.M. Beam, Clara May Beam, Abner O. Cureton  
Lillie Estelle Beam, L.P. Beam and John B. Beam, of the County of Greenville

in the State aforesaid,  
in consideration of the sum of  
Five hundred dollars and other valuable considerations DOLLARS,  
to US in hand paid  
at and before the sealing of these presents by Emma J. Beam

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release  
unto the said Emma J. Beam, All that piece, parcel or tract of land containing twenty-six and

one-half (26-1/2) acres, more or less, situate in the County of Greenville, State aforesaid,  
branch waters of Saluda River, bounded by lands of Garrison Eskew and others, having the  
following metes and bounds: Beginning at a small black oak on Garrison-Eskew's corner;  
thence south 81-3/4 East 24-80 chains to a stone 3x on old line; thence North 5-3/4 East  
11-18 to a stake 3X, crossing a road; thence North 80-1/4 West 22 to a stone 3X; thence South  
20 West 11.60 chains to commencing black oak; being same land conveyed to J.P. Beam by  
T.J. Ligon, deed dated January 18th, 1900, which said deed is recorded in R.M.C. office  
for said Greenville County in Deed Book JJJ, page 324.

The grantee herein being the widow of the said J.P. Beam, who died intestate, seized in fee  
simple of said land, and the grantors being his children, except Abner O. Cureton, who is  
the husband of the deceased child- Nellie Beam Cureton, the said Nellie Beam Cureton having  
died intestate, leaving her said husband, Abner O. Cureton and the grantors and grantee her  
sole heirs and distributees.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to said premises belonging, or in anywise incident or  
appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said  
Emma J. Beam, her  
heirs and assigns, forever.

AND she do hereby bind  
herself, and

heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said  
Emma J. Beam, her

heirs and assigns, against  
and

heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
