KNOW ALL MEN BY THESE PRESENTS, That

In the State aforesaid,
in consideration of the sum of
\$500.00 Five hundred and Fifty-five and 75 cents DOLLARS,
to J. C. M^o Clinton in hand paid
at and before the sealing of these presents by J. C. M^o Clinton of Greenville, S.C.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release
unto the said J. C. M^o Clinton his heirs and assigns forever.

"All that certain piece, parcel or lot of land
situate on the west side of Maynard Street between
Springton Street and Alannah Street in Ward 5 of the City
of Greenville, and known as lot #2 of a part of the property
of the Graytor Heron, said tract having been made by
H. C. Jones dated March 31, 1913, said lot having the
following lines and corners:

Beginning at an iron pin in west line of
Maynard Street, sixty (60) feet from the corner of property
owned by Alannah Lee, this beginning point being the
southeast corner of lot #1 of said tract, thence with line
of Maynard Street 18'-2 1/2" Sixty (60) feet to an iron pipe
pin point being the northeast corner of lot #3 of said
plat; thence along the line of last mentioned lot 7'-6"-2 1/2"
one hundred and seventy-six feet (176.3) and three inches
to an iron pin in line of lot now or formerly owned by
Frank Cope; thence in the line of last mentioned lot
18'-3 1/2" Sixty seven feet (54.6) and six inches to an iron
pin, this point being the southwest corner of lot #1 of
said plat; thence with the line of last mentioned lot
8'-7 1/2" one hundred and eighty-nine feet (179.6) and
six inches to an iron pin, beginning same."

Greenville County.
