KNOW ALL MEN BY THESE PRESENTS, That J. M. A. Brazzale, of the City and County of Greenville

in consideration of the sum of Five hundred and other valuable considerations DOLLARS,

at and before the sealing of these presents by H. B. Poole

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said H. B. Poole

All that certain piece, parcel or lot of land situated, lying and being in and of the City of Greenville, County and State aforesaid, same being known as lot #10 of that of course street property of M. C. Cleveland, plat of same being recorded in R. M. C. Office for Greenville County in private plat book of Cleveland & Williams, and being further described as follows:

Beginning at a point on Lounge Street, corner of Neal Street, and running thence along Lounge Street, N. 24.0 C., 68 feet to corner of Lot #11, thence along side of Lot #11, N. 76.0 H., 147.6 feet to point on a 10 foot alley, thence along said alley, S. 14.0 H., 67.5 feet to a point on Neal Street, thence along said Neal Street, S. 76.0 C., 18.9 feet to the foregoing corner, this being the same lot of land conveyed me by H. C. Cleveland by his deed dated October 17, 1912 and recorded in R. M. C. Office for Greenville County in Volume 21 at page 285.
