All that piece, parcel or lot of land, situate
 lying and being in the City of Greenville, in the
 County and State of South Carolina, adjoining lots now or
 formerly of Mrs. R. Cole and Mr. A. Allison and being
 the right side; beginning at and iron pin on the
 Northwest side of Mulberry St. and running thence
 along said st. approximately N. 57 1/2 E. seventy and
 one half (70 1/2) feet to the corner of Mulberry & Pinckney
 st.; thence along said Pinckney St. in a North-
