in the State aforesaid, for and in consideration of the sum of Six Thousand and no/100 (\$6000.00) DOLLARS, to me in hand paid at and before the sealing of these presents by Mrs. E. H. Howe, as Trustee of the City and County of Florence, in the State aforesaid

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Mrs. E. H. Howe, as Trustee, her successors,

heirs and assigns, forever. No. 1. That certain tract of land situated in the County of Florence, State of South Carolina, containing one hundred and twenty-six (126) acres, as shown by survey by J. M. Rhodee Surveyor, made on September 10, 1911, and bounded as follows: To wit: On the North by lands of Wm. F. Howe; on the east by lands of S. M. Gregg; on the south by lands of G. C. Willoughby; and on the west by estate of lands of Mrs. J. M. F. Howe, being the same tract conveyed to the said Mrs. E. H. Howe by S. M. Gregg by deed dated October 2, 1911, and recorded in the office of the Clerk of Court for Florence County, in Book "A" at page #30, hereby conveyed are subject to a certain mortgage made by Mrs. E. H. Howe to J. M. Roddall and the payment thereof is hereby assumed by the grantee herein. No. 2.

Also, all my right, title and interest in and to the estate of my grand-mother, Mrs. Rebecca C. Honours, including my undivided interest in real estate belonging to my grand-mother's said estate in Greenville County, South Carolina, and also all my right, title and interest in and to all the personal property of every kind and description belonging to the said estate of my grand-mother, my interest in said estate being but undivided one-eighth share thereof; all of which was heretofore conveyed to me by Mrs. E. H. Howe by deed dated December 31, 1915, and recorded in the office of the Clerk of Court for Greenville County in Book "G" page 118.
