(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *J. B. Lockhart*

All that certain lot or piece parcel of land situate in County and State aforesaid, in Glassy Mountain Township on both sides of Jamisons Mill Creek Beg running at a large white P. 3 X old running thence S. 44 1/2 E. 7 1/2 ch. to a stone, thence N. 35 1/4 E. 32 1/4 ch. to stone in place of Hickory post gone, thence S. 83 1/2 W. 14.30 to a pine stump, thence S. 34 W. 19.80 ch. to a stone, thence S. 24 1/2 E. 2.76 ch. to beginning corner, containing Twenty seven and one sixth (27 1/6) acres more or less. Known as the A.C. Campbell land.
