R. E. Rollins, all those two certain pieces, parcels or lots of land situate lying and being near the town of Greenville County and State aforesaid, being part of property of Louise M. Cottingham and Mannie M. Zimmerman Estate, and known and designated as Lots nos. 5 and 6 on plat recorded in Plat Book E. page 135 and being more particularly described as follows:

Lot No. 5: Beginning at a point on the north side of 19th St. S.E. corner of lot no. 6, and running thence along said street S. 88-35 E. 100.2 ft. to corner of lot belonging to Bennett, thence along Bennett's line N. 3-35 E. 135.8 ft. to an iron pipe, thence along line of lot no. 3 N. 245.6 E. 20.7 feet to corner of lot no. 4, thence along line of lot no. 4 N. 86-14 W. 70 ft. to iron pipe, corner of Rollins' lot, thence along Rollins' line N. 87-10 W. 74.2 ft. to corner of lot belonging to Vaughan, thence along line of lot no. 6 S. 12-0 E. 165.5 ft. to point of beginning on 19th St.
