All that certain lot of land in Greenville Township, Greenville County, South Carolina, in Ward one of the City of Greenville, on Whittier Street, being a portion of lot No. 8 on a plat of J. E. Beattie's Buncombe Street property, copied by J. E. Sirkine from a survey made by Joe F. Lawrence on April 15, 1909, and having the following mites and bounds: Beginning at a stake on Whittier Street corner of lot No. 5, owned by Waldrop (which point is 303 feet and 9 inches from the property line on Buncombe Street) and running thence with Waldrop line in an easterly direction 178 feet, more or less, to line of lot belonging to the estate of J. G. Wells, deceased; thence along the Wells line in a southerly direction 59 feet to a stake; thence in a westerly direction 178 feet, more or less, to a stake on Whittier Street (which stake is 362 feet and 9 inches from the property line on Buncombe street); and thence with Whittier Street in a northerly direction 59 feet to the beginning corner, being a portion of the lot conveyed to me by Mary C.
