(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

A. P. Cox, all that piece parcel or tract of land
situate lying and being in Fairview Township,
County and State aforesaid and containing thirty-
nine (39) acres more or less, and having the
following bounds and boundaries:Beginning in center of branch near spring
and running thence N. $8\frac{3}{4}$ W. 5.20 chains to a stone
3 x, thence N. $9\frac{1}{4}$ E. 5.00 to stone, thence N. $18\frac{1}{2}$ W. 8.80 to
stone, thence S. $89\frac{3}{4}$ E. 7.00 to stone, thence S. $3\frac{1}{4}$ E. 8.78
to stone, thence N. $82\frac{3}{4}$ W. 0.72 to stone, thence S. 5 E.
7.30 to stone, thence East on a line 3.23 to stone, thence
S. $28\frac{3}{4}$ E. 18.81 to stone, thence S. $51\frac{1}{4}$ W. 6.80 to stone
