DEED TO Melville Westervelt, et al

KNOW ALL MEN BY THESE PRESENTS, That I, Mary Birnie Lewis, of the
County of Greenville, and

in the State aforesaid,
in consideration of the sum of
Ten Dollars and other valuable consideration DOLLARS,
to me in hand paid
at and before the sealing of these presents by Melville Westervelt, Sarah C. Westervelt,
A. M. Rickman, Wade W. Calmes

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

Melville Westervelt, Sarah C. Westervelt, A. M. Rickman
Wade W. Calmes, their heirs and assigns forever.

All that certain piece parcel and lot of land, situated
on the South side of the Augusta Road County and State aforesaid
and having the followingrites and bounds as shown on plat
of property of Mary Birnie Lewis, made by R. E. Galtow, Oct.
1909, and additional survey of February 1920, to-wit: Beginning at a
pin south side of Augusta Road on corner of property now or formerly
of Judy Nesbitt thence S. 34.04 W. 111 feet to an iron pin on line of
property belonging to J. O. Lewis; thence N. 60.7 W. 311.8 feet to stow; thence
N. 17.47 E. 90.2 feet to an iron pin on corner of Calhoun prop-
erty and Augusta Road; thence with Augusta Road S. 44.30
E. 486.5 feet to the beginning corner.

It is understood and agreed that the thirty foot
shown on said plat is to remain open for the joint use
of the grantees ^{herein} their heirs and assigns, the grantor
their heirs and assigns, and J. O. Lewis, his heirs and
assigns.

The grantees herein by accepting this deed, assume
and promise to pay a certain promissory note ex-
ecuted by Mary Birnie Lewis to Lucy S. Jordan
on May 31st 1919, in the sum of Ten Thousand
(\$10,000.00) Dollars due one year after date, at seven
per cent payable annually and secured by a
mortgage covering the above described property, re-
corded in R. M. C. Office for Greenville, S. C., in vol.
75, Page 169, which mortgage and mortgage in-
debtedness the grantees expressly assume and promise
to pay, together with interest as above provided from
May 31st 1919, until paid.

The property herein conveyed being the same
conveyed to me, Mary Birnie Lewis, by Lucy S. Jordan
by deed dated May 31st 1919, recorded in said R. M. C.
Office, in vol. 54, page 26.
