KNOW ALL MEN BY THESE PRESENTS, That I, Mary F. Goldenwith of Greenville County,

in the State aforesaid,
in consideration of the sum of
Four Hundred and Twenty-five (\$425.00) DOLLARS,
to me in hand paid
at, and, before the sealing of these presents by J. S. Elmore

(the receipt, whereof, is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

J. S. Elmore his heirs and assigns forever. All that certain parcel of land in the County and estate aforesaid on the Rutherford Road, known as designated upon a plat of the lands of Mary F. Goldenwith made by William D. Reeves, Esq. January 1917, as lots no. 16, being more particularly described as follows: Beginning at a stake at the southwest end of bridge on Cherry Dale Drive and on the southern right-of-way line of the Paul M. Railroad, running thence S. 19 E. one hundred fifty one feet to an iron pin corner, being the front corner of lot 16, thence with line of lot no. 1 S. 86 3/4 W. 384.5 feet to an iron pin corner on the Rutherford Road, thence with the Rutherford Road N. 4-30 W. one hundred sixty feet to an iron pin corner on the southern right-of-way line of the Paul M.
