(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

Ray Robinson and his heirs and assigns forever:

(1) All my undivided one-half ($\frac{1}{2}$) interest in and to all that certain lot or parcel of land situate in the city of Greenville in the County and state aforesaid, containing 425 square feet more or less, and having the following lines and bounded to-wit, Beginning at a stake on M. C. Bee Avenue at the corner of lot of M. C. Bee, thence along M. C. Bee Ave. N. 68 W. fifty (50) feet to an iron pipe, thence S. 22 W. 145 feet to a stake on test spot alley; thence along same S. 68 E. fifty (50) feet to a stake, thence N. M. C. Bee line N. 22 E. 145 feet to the beginning corner, and being the same lot of land conveyed to C. D. Wilson and J. L. Lane, by deed recorded in R. M. C. Office for Greenville County in Vol. 56 at page 330.

(2) Also all that other certain piece, parcel or lot of land, situate lying and being just outside the incorporate limits of the city of Greenville, County and state aforesaid on the south side of Miles Avenue and having the following lines and bounded to-wit:

Beginning at an iron pipe on the south side of Miles Ave. 132 feet, west of Ladson St. at first corners of lots three and five and running thence with line of said lots S. 44-33 E. 180 feet to an alley 16 feet wide thence with line of said alley S. 44-27 W. 66 feet to right corners of lots four and seven, thence along line of said lots N. 44-33 W. 180 feet to Miles Avenue, thence along south side of Miles Avenue N. 40-27 E. 66 feet to the beginning corner, and being the same lot of land conveyed to me by Susan C. Miles, by deed recorded in R. M. C. office for Greenville County in Vol. 57 at page 37.

As a part of the consideration for this conveyance, the grantee herein assents and agrees to pay the principal and interest of a mortgage given by grantor to Mrs. Susan C. Miles, bearing date Sept. 11th 1919, recorded in Vol. 80 at page 59, in the sum of Thirteen Hundred (\$1300.00) Dollars, bearing interest at seven per cent per annum.

Further as a part of the consideration for this conveyance grantee assents and agrees to pay grantor one-half interest in principal and interest of a mortgage in the sum of Eighty-five Hundred (\$8500.00) Dollars, bearing interest at seven per cent per annum given by J. L. Lane and C. D. Wilson to J. C. Cole, December 10th 1918 and recorded in R. M. C. office for Greenville County in Vol. 79 at page 286, said mortgage covering lot fifty above described.
