(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

C. F. Woodside, all those two pieces, parcels or lots  
of land on the east side of Maple St. in the town  
of Simpsonville, County and State aforesaid, having  
the following metes & bounds: beginning at a stake  
on Maple St. on corner of lot formerly sold by me  
to said C. F. Woodside (which point is one hundred and  
twenty (120) feet from the corner of Maple & Trade  
sts. in a N.W. direction), and running thence along  
said street N. 14 W. One Hundred and twenty (120)  
feet to corner of lot known as #14 of my land  
according to plat by J. A. Adams dated April 4,  
1909, thence along said lot N. 76 E. One hundred and  
fifty (150) feet to corner of lot in rear known as #13
