the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said.

B. P. Alberson, his heirs and assigns forever, the following described real Estate:
"All that lot of land situate near the City of Greenville, in the County of Greenville and State of South Carolina, fronting 56 feet on Mason Street and running back in parallel lines a distance of 100 feet and being the rear portion Lots nos. 7 and 8 in Block B, of the Melville Land, according to plat recorded in Plat Book "A" page 97, R.M.C. office for Greenville County, reference to which plat is made for a more complete description and being the same lots conveyed to the said D.
