## COURT OF COMMON PLEAS.

TO ALL WHOM THESE PRESENTS SHALL COME:

I, *E. Inman*

Master in and for the County aforesaid, SEND GREETINGS:

WHEREAS,

Lilie A. Kelly, Mae Bonestel, Mattie Roark and Warren  
D. Kelly, Executors under the will of L. K. Kelly, deceased  
and individually

on or about the 28th day of December, in the year of our Lord nineteen hundred and twenty-one, exhibited their complaint in the Court of Common Pleas, for the County aforesaid, against American Banker & Trust Company, a corporation, et al

M.H. Kelly and his heirs and assigns forever, the following described real estate: "All those two certain lots of land situate in the Town of West Greenville, County of Greenville and State of South Carolina, and fronting on Aiken Street and being known and designated as Lots Nos. 2 and 3 according to subdivision and plat of the estate of L.K. Kelly deceased made by R.E. Dalton, Engr., in January 1922, and having the following metes and bounds and courses and distances, to-wit:

Lot #2: Beginning at a point on the northwest side of Aiken Street 81.6 feet from the corner of Aiken Street and Pendleton Road, this being the common corner of lots 1 and 2, running thence N. 46° 07' W. 49.1 feet; thence S. 44° 30' W. 22.7 feet to an iron pin; thence S. 72° 30' W. 41.7 feet to an iron pin corner of lot No. 3, thence along the line of last mentioned Lot S. 45° 37' W. 69.3 feet to a point on Aiken Street; thence along the line of said Street N. 43° 53' E. 60 feet to the beginning corner.

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said,

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining; and all the estate, right, title, claim and interest whatsoever, of the parties to the cause aforesaid, and of each of them in and to the same; and of all other persons rightfully claiming from, under, or by these or any of them.

TO HAVE AND TO HOLD, all and singular the premises before mentioned, unto the said *M. J. Kelly*, and his

heirs and assigns forever.
