Keith his heirs and assigns forever*, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *All that piece parcel and lot of land in the city of Greenville, County and state of South Carolina, on the south side of Stone Avenue, between Main and Bowley Streets, upon which is now situated a fine-some cottage, known and designated as 124 E Stone Avenue being described as follows. Beginning at an angle in the south side of Stone Avenue and running thence of 15 feet (56) feet, two and one-half (1 1/2) inches to a stake at N. E. McCains corner, thence S. 90-19 W. with N. E. McCains line. One hundred and seventy-five (175) feet to a stake; thence N. 69-24 W. fifty-six (56) feet, two and one-half (1 1/2) inches to a stake in due west now formerly owned by C. H. Rockey, thence with said Rockey's line N. 21-19 E. one hundred and thirty-five (175) feet to the beginning corner as shown on the plat made by J. E.
