H. Frank Smith his heirs and assigns the following described real estate
to wit:*

*(First) all that certain piece parcel or tract of land, situate lying and being
in the State of South Carolina and County of Greenville, in the
Township of the Stanton Bridge, and having the following
corners and bounds to-wit: Beginning at an iron pin corner of Ed. Stofell
land in said Stanton Bridge, and running thence N. 68. 56 W. 151.5
feet to an iron pin W. L. Johnson land and running thence S. 24. 35
W. 104.14 feet to an iron pin thence S. 81. 27 W. 143.7 feet to an iron
pin on Stanton Bridge Road; thence with said road N. 42. 01 E. 60 feet
to an iron pin; thence N. 53. 57 E. 276.7 feet to an iron pin; thence
N. 25. 37 E. 191 feet to an iron pin; thence N. 16. 02 E. 234.2 feet to
iron pin the beginning corner and containing 30 acres, more or less
less five (5) Acres sold and conveyed theretoward to W. R. Casan dead

consideration of this deed.*

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining,
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said *H. Frank Smith and his*

heirs and assigns, forever.

heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said *H. Frank Smith and*

and *my* heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
