the receipt whereof I, the undersigned, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
F. S. Davenport, his heirs and assigns, all
that certain lot, piece or parcel of land situate, lying and
being in the City of Greenville, County of Greenville,
in the State of South Carolina, known and
designated as lot No. 10, block 10, The Republic formerly belonging
to the Mountain Home Improvement Company, according
to a plat thereof, bearing in the book of the Register of Deeds
conveyances for said County and State in Book "WW" of
Plats, at page 22, as follows, according to such plat, the
boundary lines and boundaries being, beginning at a stake
on the west side of Jones Street approximately midway
between Stone Avenue and Carl Street, and running thence
142 1/2 feet hundred and fifty (150) feet to a stake on
Jones Street, thence 54 1/2 feet (150) feet along line
to lot 10, then to corner of lot "K", thence N. 84 1/2 W. one
hundred and fifty (150) feet along lines by lots "K", "L",
and to a stake on Jones Street, thence across said
lot 10, 54 1/2 feet (150), to the rearing corner, this
being the same lot of land conveyed to me by H. Mullins
by all bearing date February 2nd, 1926, and
