(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Begrave, Sell and Release unto the said Joe B. Pruitt and Anna Ruth Pruitt, and their heirs and assigns all that certain lot, piece or parcel of land situate, lying and being in the State of South Carolina, in the County aforesaid, townships of Greenville, a short distance west of the corporate limits of the City of Greenville, and west of a subdivision known as "Park Place", near lands of American Surveying Company and lands of F. W. Poe Surveying Company, the lot hereby conveyed being known and designated as lot number thirteen (13), according to a survey made for said L. D. Patterson by the late Mrs. A. Hudson (being a part of lot 35 on one acre plot of the H. T. Hammett lands, dated July 3, 1908); the lot hereby conveyed having the following lines and bounds according to said Hudson Survey, to wit: Beginning at a stake on the north east side of Pinckney Street (now usually called Salley Street), on the west corner of lot no. 12 of said survey (said stake being approximately one hundred and thirty-six and two-thirds feet from the corner of Pinckney and Goldsmith Streets), and running thence N. 21° 5' E. one hundred and ninety (190) feet along line of lot No. 12 to a stake on a ten foot alley, thence along said alley N. 68° 18' W. sixty-six and two-thirds (66-2/3) feet to a stake on said alley, on the corner of lot no. 14; thence along line of last mentioned lot S. 21° 18' W. one hundred and ninety (190) feet to a stake on said Pinckney Street; thence along said Pinckney or Salley Street S. 68° 45' E. sixty-six and two-thirds (66-2/3) feet to the beginning corner, this being a part of the lot conveyed to me, the said L. D. Patterson, by Mrs. Goldsmith Jr. by deed bearing date June 12th, 1906, and recorded in the Office of the Register of Deed Conveyances for said County and State on June 13th, 1906, in Deed Book "555", at page 393.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said

Joe B. Pruitt and Anna Ruth Pruitt, and their

heirs and assigns, forever.

It being understood and agreed, however, that the said L. D. Patterson hereby reserves himself and excepts from the operation of this deed the right to said grantor and his heirs and assigns at any time or times to lay, maintain, repair and replace one or more pipes across and through the lot above described, for the purpose of conveying water from the water main on said Piney or Salley Street (any and all of the lots fronting on Salley Street) now or formerly belonging to said owner or holder of damages to building or crops situated on said lot hereby conveyed which may result from the laying, maintaining, repairing or replacing of said water pipes, which be paid to the person then owning said lot no. 13 by the person or his heirs or assigns.
