Beginning at a post on Forrest Street in the City of Greenville at the corner of lot number 21 and running west along Forrest Street, one hundred four (104) feet to an iron pin in the side walk on the line of the Southern Railway property; thence, along said Railway property, forty-four (44) feet to an iron pin at the corner of the Southern Railway right-of-way and the Piedmont and Northern Railway right-of-way, thence along the Piedmont and Northern right-of-way one hundred eighty-seven (187) feet to an iron pin on the line of lot number 23; thence, along the line of said lot number 23, thirty-two (32) feet to a post, a corner of lot number 21; thence along the line of lot number 21, one hundred eighty (180) feet to the beginning point, and being a portion of the lot conveyed to the Greenville Spartanburg and Anderson Railway Company by deed of J.
