(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Mrs Julia Cole & William W. Cole, their heirs and assigns, all that certain lot or parcel of land situated in the State of South Carolina, Greenville County, about 2 1/2 miles North of the City of Greenville, and in part division known as Fairview Hill, and being more and designated as Lot 220.51 Block 8, according to a plat recorded in R.M.C. Office for Greenville County, in Plat Book A, page 518, which having the following, metes and bounds to wit: Beginning at a pin on the West side of Furman Road, joint corner with Lot 220.50 said running thence along joint lines of lot 220.50, 21.57-25 W, one hundred and eighty (80) feet to a pin, thence 21.12-30 E, sixty-one and one-half (61.6) feet to a pin, thence 3.57-25 1/2 along joint lines of lot 220.52, one hundred and eighty-two (82) feet to a pin on Furman Road; thence along said Furman Road 8.13-30.3h. sixty feet and five inches, (60.5) to the beginning corner. This being the same lot of land conveyed to Eva H. James by the Suburban Land Company, by deed dated September 14th, 1918, and recorded in R.M.C. office for Greenville County, in Book Vol. 29 page 429. This being the same lot of land conveyed to me by Joe H. Grace, by deed dated December 1919, and recorded in R.M.C. Office for Greenville County in Book Vol. 54 page 796. As a part of the consideration for this deed the grantee agree and agree to pay my note and mortgage to the Greenville Building & Loan Association for the sum of \$4,100.00 of which \$400.00 has been paid. This mortgage was given January 9th, 1920, and recorded in R.M.C. office for Greenville County in Book Vol. 69 page 73.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said, Mrs Julia Cole & William W. Cole, their heirs and assigns, forever.

heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said, Mrs Julia Cole & William W. Cole, their heirs and assigns, against

heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
