(The receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *B. H. Deason* all that certain lot of land situated lying and being in Ward One of the City of Greenville, County of Greenville, State of South Carolina, on the West side of Buckhead Street, having the following metes and bounds to wit:

Beginning at a stake on South side of Buckhead St. and running thence N. 28° E. 14 1/2 feet to a stake thence N. 77° 20 1/2 West to another post thence N. 33° 14 1/4 feet to an iron pin thence N. 57° 40' E. 200 feet to the beginning corner. Being the same lot of land conveyed to me by deed of *B. H. Deason* by date Sept. 15, 1920. Deed not yet recorded.

As a part of the consideration of this land the grantor herein assumes and agrees to pay the unpaid portion of a mortgage given by *W. C. Wallace* to *J. J. Proke* dated July 29, 1914 in full amount of \$2000. payable in four equal installments of \$500. each, in cash, one since and three by promissory notes since date. The said mortgage further being 1920. Said mortgage bearing interest at the rate of 7% payable semi-annually. The grantor herein assumes payment of interest account of said mortgage from date of this conveyance.

The grantor herein also assumes and agrees to pay a second mortgage established by deed of *B. H. Deason* to *W. C. Wallace* in the sum of \$44500. dated Sept. 1, 1920 and recorded in vol. 96 page 119. Said mortgage payable in five installments as follows: \$1000. Jan. 1, 1921; \$1000. Jan. 1, 1922; \$1000. Jan. 1, 1923; \$1000. Jan. 1, 1924; \$1000. Jan. 1, 1925 and \$800. Jan. 1, 1926. Said mortgage bearing interest at 8% payable semi-annually. The grantor assumes payment of interest account of said mortgage from date of this conveyance. There being situated a two story residence dwelling on said lot.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said

B. H. Deason, his
heirs and assigns, forever.

heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said

B. H. Deason, his
heirs and assigns, against

all and singular, the said premises, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
