All those certain pieces, parcels and lots of land, situate being and being in and near Greenville, County and State aforesaid known as Lot nos. 23 and 24 and two-thirds of Lot no. 22 (as a depth of 110 feet by the frontages of 60 feet of lot no. 22 on Norwood street) on plat known as Plat no. 1 of Brandon Subdivision, and being more particularly described as follows:

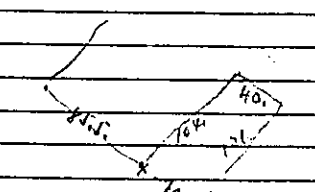
