(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said C. C. Clinkscales his heirs and assigns

that certain lot of land situate in the City of Greenville, County and State aforesaid, on the South side of East Court Street, being Lot No. 2 on plat made by R. E. Daiton, Engineer, December 1919 and having the following metes and bounds, to-wit:-

Beginning at a point corner of present wall at the intersection of East Court Street and a court, thence with line of East Court Street S. 71-39 E. 101 feet 4 inches to a point at the Northwest corner of ten-foot-alley; thence with line of said alley S. 17-42 W. 54 feet 6 inches to point in line of Lot No. 1; thence with line of said Lot No. 70-55 W. 101 feet 2 inches to a point in said line; thence N. 17-33 E. 53 feet 2 inches to the beginning corner.
