in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said W.O. Tripp, his heirs and assigns forever

all that piece, parcel or lot of land in Garrott

Township, Greenville County, State of South Carolina.

Situate about seven and one-half miles from Greenville Court House on the Grove Road, and having the following metes and bounds, according to survey of W.L. Mitchell, Surveyor, October 11th 1921, to-wit: Beginning at the last pin in the road mentioned above, thence S. 22 W. 7.84 to an iron pin 34 old thence S. 85 1/2 W. 13.13 to an iron pin 34 old bounded on these two lines by mess. Nora B. McDaniel, thence N. 11 7/10 W. 21.75 to a new corner on the southwest side of the branch thence N. 58 1/2 E. 6.89 to an iron pin 34 old bounded by B.P.
