(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the

said B. E. Geer
All that certain tract or parcel of land situate, lying and
being in the County and state aforesaid, in Greenville
Township, on and near the Paris Road, containing 72.86
acres, more or less, and having according to the plat
of R. E. Dalton, Engineer, dated November, 1921, the following
writings and bounds to wit:

Beginning at a white oak, joint corner of Earle, Ross
and Paris Property, and running thence with Ross line
N. 27.55 E. 615.5 feet to an iron pin, thence still with
the Ross line N. 38.40 W. 878 feet to an iron pin in the center
of the Paris Road; thence with the center of said Paris
Road N. 68.03 E. 748.8 feet to a bend in the said road;
thence N. 68.30 E. still with center of said road 361.3
feet to an iron pipe, corner of lot of Sarah R. West;
thence with the line of lot of Sarah R. West S. 29.15 E. 395.8
feet to an iron pipe; thence still with the line of Sarah
R. West N. 60.35 E. 130 feet to an iron pipe; thence still
with the line of Sarah R. West N. 29.15 W. 127 feet to an
iron pipe; corner of the lot of Sarah R. West, thence still
with her line N. 69.40 E. 115 feet to an iron pin, thence
still with line of her lot N. 32.36 W. 267.8 feet, more or
less, to an iron pin in center of Paris road; thence
with center of said road N. 69.40 E. 100 feet, more or less
to an iron pin in the center of said road, at corner
of a lot originally sold by L. W. Paris; thence S. 35.57 E.
271.3 feet, more or less, to an iron pin; thence N. 56.40 E.
141.7 feet, more or less, to an iron pin in the center of a
road; thence with the center of said road S. 41.19 E. 127.6 feet, more or less
to a stake, corner of L. W. Jenkins and Paris property; thence with the
Jenkins line S. 55.77 W. 930.2 feet to an iron pipe; thence still with the
Jenkins line, S. 55.25 W. 1247 feet to a stake, corner of Earle property;
thence with Earle's line, N. 35.30 W. 806.5 feet to the beginning corner.

The above tract of land is composed of a portion of a
26.94 acre tract conveyed to L. W. Paris by J. W. West, the
deed to which is of record in vol. 46 at page 111.
A portion of this 5.80 acre tract conveyed to L. W. Paris by J. W. West,
the deed to which is of record in vol. 45 at page 272. All of this 4.92 acre tract conveyed to L. W. Paris by
D. Hilton, the deed to which is of record in vol. 34 at page 89, and all of this 4 acre tract conveyed to L. W. Paris by
Grace W. West, the deed to which is of record in vol. 41
at page 466.

As part of the consideration for this deed the grantee agrees
to pay the following mortgages to wit: (1) Mortgage of \$10,000.00
on the above tract in the County of Greenville which mortgage was taken
in 1921 and is held in trust by the First National Bank of Greenville, and
is to be paid to the First National Bank of Greenville.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances, to the said premises belonging, or in anywise incident or
appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said B. E. Geer, his

heirs and assigns, forever.

AND I myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said

B. E. Geer, his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
