(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *Piedmont Lumber Company, its successors and assigns;* all that piece, parcel and lot of land situate, lying and being in the State and County aforesaid, near the corporate limits of the City of Greenville, and having the following metes and bounds to-wit: Beginning at an iron pin on the corner of Montgomery Avenue, and Pinckney Street running thence with said Pinckney street N. 32. 04. 6. 174. 9 feet to an iron pin corner of Alexander street, thence with said Alexander street N. 53. 40. 6. 278. 5 feet to an iron pin on Montgomery Avenue, thence with said Montgomery Avenue S. 56. 11. 4. 227. 5 feet to the beginning corner, being the same lot conveyed to me by Mrs. Loula M. Briggs by deed dated Dec. 11, 1922, and to be recorded.

Also all that lot of land situate in the State and County aforesaid and near the aforesaid described lot of land, and described as follows: Beginning at the Northwest intersection of Montgomery Avenue and Pinckney street and runs thence N. 32. 37. 11. 242. 3 feet; thence S. 56. 04. 8. 44. 171. 5 feet, thence S. 57. 39. 11. 235. 7 feet to a rail; thence S. 2. 17. 6. 166 feet, thence S. 32. 17. 6. 110 feet to a pin; thence N. 57. 37. 6. 35. 2 feet, thence N. 27. 03. 6. 9. 5 feet to a pin; thence N. 56. 30. 6. along Montgomery Ave. 448. 3 feet to the beginning corner; less however, and there is excepted from the land above described and not hereby conveyed a strip twenty-five feet wide being used under contract by Southern Railway for siding located and shown by the survey of R. E. Dalton, Dec. 1922, and plot thereof which plot shows the land as above described with the right of way. There is however hereby conveyed to the grantee herein the right and privilege to have said Railway to operate said siding over and across the strip of land excepted as aforesaid for the use of the grantee, which use however shall not be exclusive but the said right of way and siding may be used by said Railway for the use of other property abutting the same as it is, or may be extended beyond the boundary line of the land above described.
