(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said R. L. Scott his heirs and assigns forever, all of our undivided interest in and to all the lands below described to wit: All that tract of land situated on the West side of White Horse Road in the County and State aforesaid including a small section between said White Horse road and Augusta Road and containing seventy-one acres more or less and hath such courses and distances as are fully set forth in the deed by Coca Cola Bottling Company, dated the 3rd day of January 1914, and recorded in Vol. 25 at page 22 to which reference is here made as a part of the description hereof.

Also there two certain tracts of land situated in Gantt Township in said County and state containing forty-two acres, more or less, also that other tract of land adjoining the last above named containing three acres, more or less, said tracts of land having such courses and distances as are set forth in the deed of E.
