love and affection I bear to the said Mary Tallulah Smith

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the
said Mary Tallulah Smith, All that tract or parcel of Land situate and lying in the County
of Greenville, about two and one-half (2 1/2) miles South of the City of Greenville on the
East side of the Augusta Road and having the following metes and bounds:
Beginning at a point 200 feet from the corner of Mount Vista Avenue and Smith Street, and
running thence along Smith Street N. 25.40 W. 200 feet to iron peg at corner of Smith Street
and Tallulah Drive; thence along said Tallulah Drive S. 64.20 W. 400 feet to iron peg; and
cornering on land owned by Mrs. C.C. Martin; thence along land of said Mrs. Martin S.
25.40 E. 200 feet to iron peg; thence along land of Mrs. W.C. Belk and C. Suber and W.W. Roe
N. 64.20 E. 400 feet to beginning corner.
Also all that other tract of land, beginning at the N.W. corner of Mount Vista Avenue and
Ioka Street and running thence with Ioka Street N. 25.40 W. 400 feet to iron peg on corner of
Ioka Street and Tallulah Drive; thence along Tallulah Drive S. 64.20 W. 1300 feet to iron peg
