(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Stephen A. Forrester and Columbus A. Forrester all our right, title and interest in all that certain tract or parcel of land lying and being in the State and County aforesaid on the West side of the East Fork of Thompson's Beaver Dam Creek:

Beginning at a stone 3x on the said creek and running thence N. $87\frac{1}{2}$ W. 9.40 to a stone 3x; thence S. 5.64 to a stone 3x; thence S. $77\frac{1}{2}$ W. 6.77 to a stone 3x; thence S. 4 E. 20.06 to a stone 3x; thence S. 37 E. 10.96 to a red oak 3x; thence S. $78\frac{3}{4}$ E. 10.50 to a maple 3x on the Bank of Beaver Dam Creek; thence up the said creek with the meanders to the beginning corner and containing $49\frac{1}{2}$ (forty-nine and one-half) acres, more or less.
