(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said D. W. Cochran, Jr. All that certain piece, parcel or lot of land in the County and State aforesaid, near the City of Greenville, in the subdivision known as "Kanatenah", and known as Lot #14, in Block "E", on revised plat of the said property to be recorded in the R.M.C. Office for said County.

The said lot has the following metes and bounds: Beginning at a stake on the South side of Cureton Street, at a bend in said Street, and corner of lot #13, and running along said lot 150 feet to stake at corner of lot #6; thence along said lot, 60 feet to a stake at corner of lot #15; thence along said lot, 150 feet to stake on Cureton Street; thence along said Street, 60 feet to the beginning point.

For value received, Southeastern Life Insurance Company does hereby release and forever relinquish unto the within named D.W. This restriction is for the benefit of the other lots in this subdivision.

heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said D. W. Cochran, Jr. and his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
