Office for said County. The said lot has the following metes and bounds: beginning at a stake on the south side of Cureton Street, 60.5 feet from the corner of an unnamed Street corner of lot #9, and running thence along Cureton Street, N. 56-21 E. 60.5 feet to stake at corner of lot #11; thence along said lot, 127.2 feet to stake at corner of lot #2; thence along said lot 60 feet to stake at corner of lot #9; thence along said lot, 119.6 feet to the beginning point on Cureton Street.
