the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said

J. B. Hudson and his heirs and assigns forever their following described real estate:

All that certain piece or tract of land, situate, lying and being in Chick Spring Township, County and State aforesaid, and being known and designated as Tract No. 1 on sub-division and plat of the lands of J. F. Freeman and S. R. Freeman, made by J.
