J. F. Freeman and his heirs and assigns forever, the following described real estate:
"All that certain lot of land situated, lying and being in the State and County aforesaid, in Chickasaw Springs Township, and in the Town of Taylors, containing 7/8 acre, more or less, and more particularly described as follows: Beginning at the corner of Flynn's lot on the National Highway and running thence along the line of Flynn's lot, S. 1/2 E. 1.98 to an iron pin; thence S. 78 3/4 W. 3.67 to an iron pin, thence N. 12 W. 1.98 to a point on the National Highway leading to Greenville; thence along the line of said National Highway, N. 77 1/4 E. 3.67 chains to the beginning corner, and being shown on a plat designated as the plat of Store lot of J. F. Freeman & Bro., made by J. Earle Freeman, Nov. 16, 1922."
