Hollingsworth, and his heirs and assigns forever, the following described real estate: All that piece, parcel or lot of land in Kleeville Township, Greenville County, South Carolina, about two miles from Greenville Court house, near the Laurens Road known as Lot No. 28 on plat of Easton, recorded in office of R. M.
