Nease and his heirs and assigns forever the following described real Estate; all that certain lot or parcel of land situate lying and being in Greenville, County of Greenville, State of South Carolina, bounded in the front by the street known and designated as lot no. 22 of the Subdivision known as "Central Heights," according to a plat made by Mr. E.
