and his heirs and assigns forever, all that piece, parcel or lot of land in the city of Greenville, on Mayfield Street, having a frontage of fifty (50) feet and a depth of one hundred thirty six (136) feet, and being the same conveyed to Annie Green by T. C. House, Nov. 12, 1887, by deed recorded in Deed Book "T.T" at page 562, in the Register's Office of Greenville County and shown on the City map in the Auditor's Office on page 51, as Block no. 2, lot no. 23.


