Be It Known, that I, Pearl Smith, the mother of Jim Allen Guy Smith, an infant male child aged five years of date February 2nd, 1927, (the father of said child being now dead), in consideration of the covenants and agreements with reference to the adoption of the said child upon the part of James William McAbee and his wife, Grace Myrtle McAbee, and of their taking into their care, custody, control and support, the said child, I do hereby grant, give, assign and release unto the said James William McAbee and Grace Myrtle McAbee, or the survivor of them, the entire and absolute control and care and the custody of the said Jim Allen Guy Smith, until he arrives at the age of twenty-one years.

By the acceptance of this deed, and of the said child the said James William McAbee and Grace Myrtle McAbee agree, jointly and severally, to properly rear, care for, support, nourish, train and educate to the best of their means and ability, the said child, to provide the necessities of life including medical attention when needed, and to use their best endeavor for the proper training and rearing of the said child, and to see that he is prepared for some work of his liking, by which he may gain a livelihood for himself when he is so required, and to grant and give to the said child all rights of inheritance. It is also agreed that the mother and child shall be permitted and allowed to visit each other at such times and for such length of time as may be convenient, agreeable or expedient.
