Know all men by these Presents that I, George Brownlee, of Greenville, Greenville County, South Carolina, for and in Consideration of the sum of \$25.00 and other valuable Considerations to me Cash in hand Paid by Farmers Loan and Trust Company, Trustee a Corporation organized under the laws of the State of South Carolina and having its place of business in Greenville, Greenville County, South Carolina, the receipt of all of which is hereby Acknowledged have granted, bargained, sold and released, and by these Presents do hereby grant, bargain, sell and release unto the said Farmers Loan and Trust Company Trustee, the following described Property situate, lying and being in the State of South Carolina and County of Greenville and more Particularly described as follows to-wit:

* 1. All that lot of land situate on the south side of Washington Street, in the City and County of Greenville, State of South Carolina, beginning at an iron Pin on said Street at Corner of lot formerly belonging to Deam; and runn thence S. 23 1/2 W. 217 1/2 feet to an iron Pin; thence S. 66 1/2 E. 68 feet to an iron Pin; thence N. 23 1/2 E. 217 feet to an iron Pin on Washington Street; thence with the south side of said Street N. 66 1/2 W. 65 feet to the beginning corner, being the same land conveyed to J. Perry Poole by J. H. O'Mall, by deed dated the 19th day of November, 1910 and recorded in vol. 9, page 105.

All that Piece, Parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, just outside of City limits of the City of Greenville and having the following metes and bounds to-wit: Beginning at a Pipe on the North side of Mills Avenue, 68.5 feet East from the East side of Ledson Street, and running thence along the North side of Mills Avenue N. 45-27 E. 68.5 feet to a Pipe, corner of lot no. 12; thence along line of lot no. 12, N. 36-14 W. 130 feet to a Pipe in line of lot no. 12, thence in a straight line S. 45-27 W. 68.5 feet to a Pipe in line of lot no. 10; thence along line of lot no. 10 S. 36-14 E. 130 feet to the Point of beginning.
