(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

A. F. McKissick: All our right, title and interest, the same being an undivided three-fourths interest, in those two certain lots of land on the East side of North Main Street in Ward One of the City of Greenville, known as Lots Nos. One and Seven on a plat of the property of A. D. L. Barksdale, et al made by R. E. Dalton, Engineer, July 1925, said plat being recorded in R. E. C. Office for Greenville County in Plat Book 9, page 51, said lots being more particularly described by notes and bounds, as follows:

Two - Lot No. 1- Beginning at an iron pipe on the east side of North Main Street on the N.W. corner of the property of Jane H. Serrine, thence with her line S. 68-40 E. 176.5 ft. to an iron pipe on 25' Street or Alley; thence with said Street or Alley N. 18-07 E. 22 ft. to a point on said street or alley; thence N. 68-40 W. 176.5 ft. to an iron pipe on North Main Street; thence with said street S. 18-07 W. 22 ft. to the beginning corner.

Lot No. 7- Beginning at a point on the North edge of cement post on Brown Street, being the N.E. Corner of the property of Jane H. Serrine; thence with her line N. 68-40 W. 90 ft. to an iron pipe on 25' street or alley; thence with said street or alley N. 18-07 E. 43.8 ft. to an iron pipe S.W. corner of Lot No. 6; thence with said lot S. 60-14 E. 97.7 ft. to an iron pipe on Brown St.; thence with Brown St. S. 29-30 W. 29.8 ft. to the beginning corner.

The property of which the above described lots are a part was conveyed by Ella McGee Gear to A. D. L. Barksdale, et al. March 10, 1920 By deed recorded in Vol. 64, page 182; the interest of W. E. Moser in said property was conveyed to A. D. L. Barksdale, et al. by deed dated March 10, 1921, recorded in Vol. 33 page 137; the interest of J. A. Bull therein having been conveyed to A. D. L. Barksdale, et al. by S. D. Willis, Sheriff of Greenville County, and J. A. Bull by deed dated April 16, 1925 and recorded in Vol. 101, page 401, the grantors and grantees being now the whole owners of the lot hereinabove conveyed.
