(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Ed A. Knight, all of two certain tracts of land described below, situated in Dunklin Township, State and County aforesaid. One containing one hundred and four and twenty-two one-hundredths (104.22) acres, more or less. Being the greater portion of tract No. 1 of the Estate of Mrs. F. E. Stokes, deceased, and branch tributary to Mountain Creek, waters of Saluda River. Beginning at stone 3x0; thence N. 44 $\frac{1}{4}$ E. 5.45 stake 3x0; thence Due East 3.83 post 3x0; thence N. 84 E. 5.95 stake 3x0; on old line; thence N. 18-3/4 W. 3.30 P.O.-stump and stone X0; thence N. 35 E. 30.75 stone 3x0; thence N. 8-3/8 E. 13.79 stone 3x0. Bounded by a tract this day conveyed to Miss Jean Knight; thence Due West 16.37 stone 3x0, N. 42-2/5 W. 20.02 stone 3x0. Bounded by the C.B. Davenport Estate, S. 57-1/2 W. 4.76 stone 3x0. Bounded by L. D. Huff, thence S. 36-1/2 E. 6.33 stake 3x0, S. 57-3/4 W. 6.35 to corner in road. Bounded on the last two lines by the Chandler School Lot, thence along road S. 32-1/2 E. 7.36 angle S. 31 E. 8.00, S. 36-3/4 E. 3.00 angle, S. 45 E. 4.00 iron x in road at fork; thence along another road S. 45-3/4 W. 6.00 corner in road, thence S. 7-1/2 E. 12.00 stake 3x0 S. 52 W. 15.54 stake 3x0 on old line. my Heirs and all others, heirs, and against every person whomsoever lawfully claiming, or to claim the same, or any part thereof.
